The qualification and experience prescribed for the post of Professor should be considered essential for the post of Principal.
Professor	b) A postgraduate qualification in the subject / specialty concerned included in the schedule to Indian Medicine Central Council Act 1970. i) A post graduate qualification is relaxed to the teachers who had been appointed in Ayurveda Colleges on or before 01/07/1989 and are in the continuous service since then. ii) If the Post-graduate qualification holders in the concerned subjects are not available, the post-graduate qualification obtained in the subject as mentioned in IMCC (amendment) regulations, 1989 against that subject, shall be admissible.	The total teaching experience of ten years in the subject is necessary out of which there should be five years teaching experience as a Reader / Assistant Professor or ten years experience as a lecturer in the concern subject wherever the post of Reader / Asst. Professor does not exists.
Reader	c) Adequate knowledge of Sanskrit. d) For the post of lecturer in Sanskrit, M.A. in Sanskrit or Acharya from a recognized institutions or equivalent with due experience. Preference should be given to those possessing Ayurved qualifications also.
